In the long term, the department cooperates with these universities within the Erasmus programme. In years 2012-2014 the university jointly organised 2-week long intensive programmes focused on the human resources management in social and health organisations. Each year, 10 students from each country had a chance to participate in the programme. The first meeting took place in Finnish city of Lahti in May 2012, the second one was organised by the employees in Portuguese Évora. In May 2014 the programme took place in Prague.
